**OFFICE MEMORANDUM**

Dated Aizawl, the 18<sup>th</sup> February, 2022

**Subject : Payment of Dearness Allowances to employees of the Government of Mizoram.**

The undersigned is directed to convey sanction of the Governor of Mizoram for payment of enhanced Dearness Allowance to regular employees of the Government of Mizoram @ **28 % of basic pay w.e.f. 01.03.2022** (enhanced by 11% from the existing rate of 17% to 28%) on the following conditions:-

1. The enhanced portion of Dearness Allowances shall be impounded into GPF accounts in respect of all regular employees.
2. The enhanced portion of Dearness Allowances shall be paid in cash to employees retiring within 3 (three) months from the date of issue of this Office Memorandum, Income Tax Payers and to employees governed by New Pension Scheme (NPS) as well as to employees not eligible to subscribe to General Provident Fund.
3. The term “Basic Pay” in the revised pay structure means the pay drawn in the prescribed Level in the Pay Matrix Table but does not include any other type of pay like special pay, etc. However, Non-Practising Allowance, where admissible, shall be taken into account for calculation of Dearness Allowance.
4. The Dearness Allowances will continue to be a distinct element of remuneration and will not be treated as pay within the ambit of FR 9 (21).
5. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and fraction of less than 50 paise may be ignored.
