- 3) Tunlaia Mizoram hmun hrang hranga Hotel, Restaurant, Club, Homestay, Recreation Centre, Picnic Spot etc. thenkhata zu, wine leh beer in tur leh lei tur atana hmuh tur awmte pawh hi MLP Amendment Act 2025-in a khap avangin man theih vek an ni a, dan bawhchhetute pawh na taka hrem theih an ni a, hetiang dan bawhchhiatna dapchhuahna hna pawh ngawrh taka kalpui mek a ni.
