ORDER

WHEREAS Memorandum of Charge was framed against C/438 R. Malsawmdawngliana, Office of the Superintendent of Excise & Narcotics, Aizawl District, Aizawl vide this office order even no. dt.22.03.2018 under Rule 16 of the CCS(CCA) Rules, 1965 by giving him reasonable opportunity of being heard in respect of charges framed against him. The said C/438 R. Malsawmdawngliana wholly admitted the charges framed against him by making a written statement of representation received by the undersigned on 10.04.2018. The Disciplinary Authority feels further Inquiry not necessary.

AND WHEREAS the pith and substance of the charges framed against the Charged Officer is that the said C/438 R. Malsawmdawngliana, while functioning as Excise & Narcotics Constable in the Office of the Superintendent of Excise & Narcotics, Prosecution Branch, Aizawl was responsible for the escape of the accused from the custody on 06.02.2018. He was detailed to receive accused from Anti Narcotics Squad by his senior C/234 K. Vanlalruata. As instructed he received the accused including Zirliani (48) w/o Vanlalrova of Tahan, Myanmar from C/517 Lahrlinsanga Varte, C/542 C. Ramthansiami and C/546 Lalsiamkima from Anti Narcotics Squad. In the course of performing his duty by guarding the accused persons one of the accused namely Zirliani escaped from the custody and was nowhere to be seen and escaped from the clutches of the custodian. Due to his negligence, the accused escaped which shows his negligence and devotion to duty.

AND WHEREAS on careful consideration of the representation submitted by the said C/438 R. Malsawmdawngliana and the case records taking into account the gravity of misconduct committed by the Excise & Narcotics Constable, the undersigned considers that the said C/438 R. Malsawmdawngliana deserves leniency but with stern warning;



Notification No. A. 19018/1/2011-VIG dated 27.05.2013 the undersigned hereby orders imposition of minor penalty of **Censure** upon the said C/438 R. Malsawmdawngliana with immediate effect.
