ORDER

WHEREAS K.Zorammuana Driver Grade-III, Office of the Assistant Commissioner of Excise & Narcotics, Mamit District, Mamit had been convicted on a criminal charge under section 43(2) of the MLPC Act, 2014 and sentenced to to undergo *S.I.* for 1 month.

AND WHEREAS the undersigned proposes to award an appropriate penalty under Rule 19 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965 taking into account the gravity of the criminal charges;

AND WHEREAS before coming to a decision about the quantum of penalty K.Zorammuana Driver Grade-III, Office of the Assistant Commissioner of Excise & Narcotics, Mamit District, Mamit had been given an opportunity of personal hearing to explain the circumstances why penal action should not be taken against him in pursuance of the provision of Rule 19 of the CCS(CCA) Rules, 1965 by giving him Show Cause Notice Vide this office even No. Dt.10.10.2018. The said K.Zorammuana Driver Grade -III submitted his written representation on 24.10.2018 which was duly considered by the undersigned.


AND WHEREAS on careful consideration of the order passed by Chief Judicial Magistrate, Mamit District, Mamit in connection with Criminal Trial No.EX(M) 52/2018 u/s 43(2) of MLPC Act' 2014 arising out of Excise Case No. MENS-49/2018 dt.19.04.2018 and in consideration of the gravity of misconduct committed by the said K. Zorammuana, Driver Grade-III during his service as Driver Grade-III who had undergone a series of warnings and reprimands. The said K. Zorammuana had also been given a number of opportunities to change his manners and conducts so as to make himself an asset to the department. In spite of the initiatives of the Controlling Officers who had done their best to discipline him, the said K. Zorammuana did not repent and mend his ways. In fact, he had also earlier been convicted by Chief Judicial Magistrate Mamit District, Mamit on 27.10.2017. As such, the undersigned come to the conclusion that retention of the said K.Zorammuana Driver Grade-III Office of the Assistant Commissioner of Excise & Narcotics, Mamit District, Mamit in service has become detrimental rather than an asset.

NOW, THEREFORE, in exercise of the powers conferred by Rule 12(2)(b) and 19(i) of the CCS (CCA) Rules, 1965 read with Govt. Notification No. A. 19018/1/2011-VIG dated 27.05.2013 the undersigned hereby orders a **major penalty** of removal from service which shall not be a disqualification for future employment under the Government as per the provision of Rule 11 (viii) of the CCS(CCA) Rules,1965 with immediate effect.
