TERMS AND CONDITIONS

- 1) The liquor company shall register itself to the Commissioner, Department of Excise and Narcotics, Government of Mizoram on payment of non – refundable registration fee of Rs. _____ per Financial Year.
- 2) The company shall supply only good quality liquor manufactured by the distillery approved by the Commissioner, Department of Excise and Narcotics, Government of Mizoram. “Good quality liquor” herein shall mean Bureau of Indian Standard (BIS) quality.
- 3) The company shall not supply spurious liquor.
- 4) The liquor supplied by the Licencee must bear Hologram of Excise & Narcotics Department, Mizoram approved by the Commissioner of Excise & Narcotics, Mizoram. The following inscriptions “FOR SALE IN MIZORAM ONLY”, “NOT FOR SALE TO PERSONS BELOW 21 YEARS”, “DRINKING OF LIQUOR IS INJURIOUS TO HEALTH” and “MAXIMUM RETAIL PRICE (MRP)” must be printed on the labels which should be pasted/printed in a bottle/Can.
- 5) The company shall abide by the provisions of the Mizoram Liquor (Prohibition and Control) Act, 2014 and the Rules framed thereunder and must comply with all the instructions issued by the Commissioner of Excise and Narcotics, Mizoram for enforcement of the said Act and Rules, failing which the registration/license of the licencee shall be liable to suspension, cancellation with or without fines, or prosecuted as per the quantum/magnitude of breach of the conditions at the discretion of the Commissioner of Excise and Narcotics, Mizoram.
- 6) The company may also terminate this contract at any time. However, no entitlement for refund or compensation will accrue to the licencee for unutilized remaining portion of the contract period.
- 7) In the event of any dispute or differences arising between the Govt. of Mizoram and the Licencee with regard to the contract, the matter under dispute shall be adjudicated within the jurisdiction of Aizawl Courts and they may be referred to the arbitrators mutually agreed upon in accordance with the Arbitration and Conciliation Act, 1996 or any new enactment replacing, extending or modifying the same.
