OFFICE ORDER

In pursuance of Govt. Office Memorandum No.C.29018/2/2017-VIG dt.5.2.2018 and subsequent letter issued by Vigilance Department vide No. C.29018/2/2017-VIG dt.25.06.2018 the undersigned hereby inform all Group "C" staff under Excise & Narcotics Department to **File their Property Returns as on their First appointment and all Group "B" officer under Excise & Narcotics Department to file their Property Returns as on their First appointment** and to submit Annual Property Returns for the ending 31st December every year without fail. Group "D" staff are however, exempted from filing of property Returns.

It is further clarified that all Group "C" should submit/file their Property Returns as on their First Appointment only and they need not file annual property returns.


Property Returns in respect of Group "C" staff should be kept in custody by respective Controlling Officer, while property returns in respect of Group "B" staff should be submitted to the Commissionerate for further submission to the Appointing Authority for safe custody.
