1. Where ever the Word "3D" appears in the tender document may be read as "2D/3D" except "pure 3D image" appearing in the third line of second paragraph at Page No. 18 in Point No. 01.
2. In Qualification Criteria (Commercial) at Page No. 4 in Point No. 3 the word "50 Crores" appearing in the second line be read as "05 Crores".
3. In Special Terms & Conditions at Page No. 9 in Point No. 4 the words "one roof" appearing in the second line be read as "one premises".
4. In Special Terms & Conditions at Page No. 15 in Point No. 29 the word "72 hours" appearing in the second last line be read as "100 hours".
5. In Experience at Page No. 16 in Point No. 02 the word "5 (five)" appearing in the first line be read as "06 (Six)".
6. In Experience at Page No. 16 in Point No. 03 the word "5 (five)" appearing in the first line be read as "12 (Twelve)".
7. In Specification & Features at Page No. 18 in Point No. 10 the phrase "**Covert Security**: A Secret mark will be hidden inside of Label and can be verified by x10 magnified lens. The 1R ink will be printed on left side of the label, it will be verified by device and illuminated green color according to the beam on the left side of labels. The picture or letters will be printed and verified by decoding lens on the left hand side of labels. The encoding can be read in two different words in different rotation" appearing in the second column be read as "**Covert Security**: A Secret mark will be hidden inside of Label and can be verified by x10 magnified lens. Pearl Effect with covert feature which can be seen through Laser Torch. The first Text can only be visible with a special Decoder in one angle and second text will be visible at 90° angle".
8. In Security Holograms at Page No. 20 in Point No. 01 the size "15 mm (width) x 90 mm (length)" appearing in the first line be read as "15 mm (width) x 80 mm (length)".
9. In Particulars of the Tender at Page No. 25 in Point No. 14 the word "3D" appearing in the third line be read as "Conventional 2D/3D".
10. In Price Bid for Polyester based Security Hologram at Page No. 26 the size "90 mm (length) x 15 mm (width)" appearing in both columns be read as "80 mm (length) x 15 mm (width)".
